Route 43 THE WAVE – High-Frequency Service

- Rapid Transit Light one step closer to rapid transit service.
- Service from every 20 minutes to every 15 minutes.
- Effective May 18, 2025.
- Runs from the Mall at Wellington Green to the Intermodal Transit Center.
- Funded through FDOT Transit Corridor Program.
- Outreach "Catch the Wave"
 - Worked with Mosaic vendor from May 14 May 19 to promote The Wave.
 - Mosaic conducted outreach at 5 of the most active stops along Route 43.
 - Ride day was May 19 with the Palm Beach Transportation Planning Agency (TPA) and Palm Tran employees (PTSB was invited).

Bus Bridge – Crash and Recognition at the BCC

- April 11 small aircraft crashed on the Tri-Rail tracks.
- Palm Tran in collaboration with Tri-Rail and Broward County Transit created a bus bridge between Boca Raton and Deerfield Beach.
- Over 650 people transported.
- **May 6** Commissioner Marci Woodward and the Palm Beach County Board of County Commissioners recognized Palm Tran, PBC Engineering and Public Works, and Public Safety Emergency Management for its response during a time of crisis.
- 4 Bus Operators, 2 Operations Supervisors, and the Operations Manager Alicia Gray were recognized.
