## Palm Tran Announces Schedule Modifications to Several Popular Routes

Palm Tran, Palm Beach County's public transportation system, announces schedule and route improvements, beginning September 18, for Routes 20, 21, 31, 80, and 81.

[Route 20](#), serving Palm Beach Gardens crosstown to the Mangonia Park Tri-Rail station, will no longer stop on the grounds of St. Mary's Medical Center, and will now serve the hospital on Greenwood Ave. Route 20 will stop at the Palm Beach County Health Department on northbound trips. There are no changes to the schedule.

[Route 21](#), serving Palm Beach Gardens crosstown to 45th Street, will no longer stop on the grounds of St. Mary's and will now serve the hospital on Greenwood Ave. on southbound trips only. Route 21 will travel west on 45th Street, then north on Australian Ave. to MLK Blvd., then back to its existing route. Route 21 has a new schedule.

[Route 31](#), serving West Palm Beach crosstown via 45th Street, will no longer serve the Palm Beach County Health Department or St. Mary's Medical Center on 45th Street east of Australian Ave.. However, these stops will continue to be served by Route 20. Route 31 customers can transfer to Route 20 at the Mangonia Park Tri-Rail station if they wish to continue east on 45th Street. Route 31 has a new schedule.

[Route 80](#), serving Delray Beach crosstown via Lake Ida Road and Swinton Blvd., will no longer serve the SW 22nd Ave./SW 29th Street loop, but will stay on Germantown Road to Congress Ave. There are no changes to the schedule.

[Route 81](#), serving Delray Beach crosstown via Atlantic Ave., will travel down Federal Hwy. to SE 6th Street to allow safer transfers to Palm Tran's Route 1. Route 81 has a new schedule.
